- 14.5. **Misplaced Cones:** Mike S. commented on the poor cone placement at several locations at the last event. The Chairman reinforced the need to have all course workers to double check the placement of the cones and also to write down the names of all the workers at the station.
- 14.6. **Trailer tires:** need to be replaced as they will no longer hold air. We may have the wrong size wheel on the trailer. Mike S. will look into purchasing new tires.
- 14.7. **Potential X-runs turned down at the Registration table:** issue might be the run group of choice has filled to capacity.
  - 14.7.1. Lengthy discussion ensued on how to change the X-runs so that it becomes more available.
  - 14.7.2. Options discussed: changing the cap per run group from 10 sets to 15 sets of X-runs, changing from 5 run groups to 4 run groups (to increase availability of workers), increasing the number of runs for the main competition, allowing drivers to sign up for X-runs after registration closes, reimplementation of fun runs.
  - 14.7.3. Club reps were asked to go back for member comments.
- 14.8. **Practice Slalom Operating standards:** Concerns regarding the use of practice slaloms were discussed. General consensus was that the practice slaloms should be staffed by a course worker, or scheduled during the day, and should be viewable from the paddock area.
